The Downriver Council for the Arts (DCA) is currently accepting entries for the Unchained exhibit. An exploration into the intersection of Art and bike culture, artwork and installations should be inspired by bicycles and the riding culture. This can include everything from depictions of bicycles and bike culture, to objects made of bicycles and beautifully painted and designed bicycles. We encourage you to be creative with this theme!

ELIGIBILITY AND CONDITIONS

- Artists must be 18 years or older.
- A maximum of three (3) entries with entry fee may be submitted.
- Work must be original and for sale.*
- Entries should have not been in previous DCA shows.

ENTRY PROCEDURE AND FEE

- Members: \$20 for a max of three (3) entries. Non-members: \$30 for a max of three (3) entries.
- Entry fees are non-refundable. Make checks payable to DCA or Downriver Council for the Arts. We also accept credit cards at the DCA office.
- Completed form and entry fee must accompany all submissions. Please print information legibly. Mail or drop off to: Downriver Council for the Arts at the James R. DeSana Center for Arts & Culture • 81 Chestnut • Wyandotte, MI 48192

PRESENTATION

- 2-D, 3-D, mixed media, performance and installation will be accepted.
- Images may be digitally manipulated.
- Entries must be ready for installation in a professional manner. All 2-D artwork MUST be ready for hanging with wire attached. Artwork without a wire will be declined.

Each entry MUST have the following information on the BACK:
NAME - TITLE OF WORK - MEDIUM - PRICE

NOTE: DCA reserves the right to remove artwork not suitable for installation in the galleries. Any submissions not meeting these requirements will be rejected from the exhibit.

DROP OFF OF ENTRIES

Deadline to drop off entries is by Tuesday, April 25, 2017 by 3pm. Please note that you can also drop off entries on Saturday, April 22, 2017 until 5pm. Entry form must be filled out thoroughly. 2-D Artwork must be wired and properly labeled on the back with tags attached.

OPENING RECEPTION AND EXHIBIT RUN

Exhibit Run: April 28 - May 13, 2017

The reception and exhibit are open to the public at no charge. Please contact us if you can volunteer to help at this event.

PICK UP OF UNSOLD ARTWORK

All unsold works of art MUST be claimed by 5:00 p.m. on Saturday, May 13, 2017. The DCA is not responsible for artwork left after this date. You will only be contactd if your artwork is sold. You MUST pick up your artwork!

SALES

*DCA retains thirty (30%) commission for current members of the DCA and forty percent (40%) commission for non-members on the artwork sold during the exhibition. Michigan sales tax is collected on all sales. Artists will be paid no later than thirty days (30) after the close of the exhibition.

RIGHTS AND IMAGE REPRODUCTION

The DCA reserves the right to photograph/reproduce selected artists' work for the purpose of publicity and promotion.
