The Downriver Council for the Arts (DCA) is currently accepting entries for the Winter Splendor exhibit. Artwork should be inspired by winter and activities that relate to the season. We encourage you to be creative with this theme!

### ELIGIBILITY AND CONDITIONS

- Artists must be 18 years or older.
- A maximum of three (3) entries with entry fee may be submitted.
- Work must be original and for sale.\*
- Entries should have not been in previous DCA shows.

### ENTRY PROCEDURE AND FEE

- Members: \$20 for a max of three (3) entries. Non-members: \$30 for a max of three (3) entries. (Please note these fees pay for producing print materials and reception costs.)
- Entry fees are non-refundable. Make checks payable to DCA or Downriver Council for the Arts. We also accept credit cards at the DCA office.
- Completed form and entry fee must accompany all submissions. Please print information legibly. Mail or drop off to: Downriver Council for the Arts at the James R. DeSana Center for Arts & Culture • 81 Chestnut • Wyandotte, MI 48192

### PRESENTATION

- 2-D, 3-D, mixed media, performance and installation will be accepted.
- Images may be digitally manipulated.
- Entries must be ready for installation in a professional manner. All 2-D artwork MUST be ready for hanging with wire attached. Artwork without a wire will be declined.

Each entry MUST have the following information on the BACK:

#### NAME - TITLE OF WORK - MEDIUM - PRICE

NOTE: DCA reserves the right to remove artwork not suitable for installation in the galleries. Any submissions not meeting these requirements will be rejected from the exhibit.

### DROP OFF OF ENTRIES

Deadline to drop off entries is by Tuesday, November 28, 2017 by 3pm. Please note that you can also drop off entries on Saturday, November 25, 2017 until 3pm. Entry form must be filled out thoroughly. 2-D Artwork must be wired and properly labeled on the back with tags attached.

### RECEPTION AND EXHIBIT RUN

**Reception: Friday, December 1, 2017 from 6pm-8pm**

**Exhibit Run: December 1- December 22, 2017**

The reception and exhibit are open to the public at no charge. Please contact us if you can volunteer to help at this event.

### PICK UP OF UNSOLD ARTWORK

The DCA will be closed for the holidays from December 23, 2017-January 1, 2018. All unsold works of art can be picked up beginning January 2, 2018. All unsold works MUST be claimed by 3:00 p.m. on Saturday, January 6, 2018. The DCA is not responsible for artwork left after this date. You will only be contacted if your artwork is sold. You MUST pick up your artwork!

### SALES

\*DCA retains thirty (30%) commission for current members of the DCA and forty percent (40%) commission for non-members on the artwork

sold during the exhibition. Artists will be paid no later than thirty days (30) after the close of the exhibition.

### RIGHTS AND IMAGE REPRODUCTION

The DCA reserves the right to photograph/reproduce selected artists' work for the purpose of publicity and promotion.
