The DCA

The Downriver Council for the Arts (DCA) is currently accepting proposals for potential exhibitions that will take place in the James R. DeSana Center for Arts and Culture. The DCA is open to your vision. If you have a concept for your ideal exhibit, share it. The DCA will review all submissions. All media is eligible for review, as well as all types of artists, emerging to experienced.

The artist(s) will be contacted based on the outcome of the review. If the artist(s) would like to see the gallery space before the exhibition, please call and make special arrangements. Review of the gallery space **by appointment only**.

Eligibility

Artists 18 and older are eligible. Work must be original, available for sale, and have not been in previous DCA shows. Groups and arts organizations may submit a proposal for exhibit. Group shows should list a primary contact person. All media will be considered including installation, digital, performance, and video.

Entry Requirements

- Current curriculum vitae, artist statement, and/or resume
- Concept statement of the proposed exhibit
- 10-15 labeled JPEG images on a CD depicting current work
- CD list indicating title, size, medium, and price
- Any additional supporting material that you feel will be helpful for the committee to review.

Digital Format

All images must be of professional quality. Digital files should be submitted on a Microsoft windows-compatible CD in JPEG or TIF format only. The CD will not be returned. No application format file will be accepted (such as Adobe Photoshop, Microsoft Word, Adobe Illustrator, etc). Each digital file should be clearly marked with the artist's name and title of work as the file name. File size should be at least 300 dpi, larger than 800K, and not exceed 2MB. Artists submitting a proposal for media such as video, and installation, submit CD/DVD appropriate to illustrate your concept. Label CDs with your name, medium, and "DCA Call for Entries".

Presentation

Artwork that is accepted must be ready for installation in a professional manner. The backs of 2-dimensional work must have the artist's information clearly labeled with name, mailing address, phone number, email, title of work, medium of work, and price. For work that is 3-dimensional, if possible, please place identification on bottom. The DCA reserves the right to remove any artwork not represented by submitted images.

Sales

DCA retains thirty (30%) commission for **current** members of the **DCA** and forty percent (40%) commission for non-members on the artwork sold during the exhibition. Michigan sales tax is collected on all sales. Artists will be paid no later than thirty days (30) after the close of the exhibition.
